PREPAY ISSUED • Upon receipt of your prepay payment, Armor Seed will create your prepay contract and apply the gross up for that deadline. • Participating in the Armor Prepay Program results in the benefit of obtaining additional funds for seed purchases after we receive your prepay payment, but are considered "unearned" until the season end process.

INVOICING AND STATEMENTS • Any gross up eligible invoices for the current season which are dated prior to establishing your prepay contract will be automatically applied to the contract when it is created. • If prepay contract is set up by Parent, all invoices for parent and branches will draw against your Parent Prepay Contract. • If prepaying by Branch — and Parent also prepays — invoices will draw against Parent Prepay Balance when Branch Prepay Balance is consumed or contract closed. • Prepay Reports are available on Connect3® for your use in monitoring your prepay activity.
